## Introduction

This policy statement sets out North Walsham High School's (NWHHS) arrangements for managing the access of providers to pupils at the school for the purposes of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

## Student entitlement

Students in years 8-13 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through such means as letters, mail shoots, social media links, options evenings, and taster events.
- To understand how to make applications for the full range of academic and technical courses.

### **Granting access**

Where possible, we will try to meet the requests of providers.

This will include allowing providers to see students and their parents in an evening and mean that students can access a wide range of providers on one occasion. Should providers request access via an assembly, it is possible that we may offer them a place at one of the evening events. Access to events will be subject to us being able to accommodate providers and will also depend on other factors, including the date of the request, in relation to the date of the event.

### **What providers can expect once granted access**

Once access has been granted, providers can expect to be able to promote the study/training programmes that their centre offers, as well as being able to provide clear details on entry requirements and application procedures.
